**Overview:** The Eastern Region of the USDA Forest Service plans to advertise for up to three Senior Review Appraisers (1171 Series) for the Eastern Region (R-9). The positions will be filled at the GS-13 level (salary depends on duty location) and include standard Federal benefits. The positions are being offered as remote with geographic limitations, flexible telework, or traditional office. Relocation incentive or Transfer of Station (TOS) may be offered for those who prefer to be in a Forest Service office in Milwaukee, Wisconsin.

**This is NOT a vacancy announcement.** The purpose of this outreach notice is to inform potential applicants about this upcoming opportunity, and to solicit expressions of interest from potential applicants. Please circulate this Outreach Notice to as many potential candidates as possible, as we are seeking a diverse pool of qualified applicants. We have flexibility to hire from within the Federal Government or full exposure to qualified outside applicants. Based on the responses to this outreach, the jobs may be advertised on USA Jobs or filled through non-competitive transfer (for existing Federal employees at the GS-13 level). **Telework/remote eligible:** Yes, as determined by agency policy. The positions are eligible for Remote work (with geographic limitations within the Region or near a primary airport), or telework up to 8 days per two week pay period, or traditional office.

**Duties:** The Senior Review Appraiser positions are located in the Eastern Region (R-9) or remote location within the Region (typically your home). The positions will primarily support landownership adjustments (purchase, land exchange, and conveyances) as well as special uses, legislated, and other agency functions. A small portion of the work may support the Forest Legacy Program. The positions will provide a wide range of valuation services including contracting for appraisals and performing technical appraisal reviews.

**Qualification Requirements:** For the GS-13 level, the applicant must possess a Certified General license and also hold a professional appraisal designation or accreditation that requires classroom training in appraisal practice and experience requirements approved by the Appraiser Qualifications Board, as well as a demonstration appraisal report or appraisal review report, and a comprehensive qualifying examination complying with Forest Service policy. **Duty Stations:** The duty stations being considered for these positions include Forest Service Offices located within the Eastern Region (Pennsylvania, Wisconsin, Minnesota, Vermont, Michigan, Indiana, Missouri, Illinois, West Virginia, Ohio, or New Hampshire) subject to office space availability. Agency preferred locations are Milwaukee or Florence, WI. Additional consideration will be given to other offices within the Eastern United States that host public service employees or to a virtual location consisting solely of a remote work site (typically your home) without a designated government office space, subject to geographic limitations within the Eastern Region or depending on experience, within reasonable travel distance to a primary airport. Please specify your preferred duty station in the Outreach Response Form.

**About the Eastern Region:** The Eastern Region covers the states of Connecticut, Delaware, Illinois, Indiana, Iowa, Maine, Maryland, Massachusetts, Michigan, Minnesota, Missouri, New Hampshire, New Jersey, New York, Ohio, Pennsylvania, Rhode Island, Vermont, West Virginia, and Wisconsin, and the District of Columbia. It is home to 55 designated wildernesses, 20 wild and scenic rivers, 12 congressional study rivers, 5 national recreation areas, and 4 national scenic trails. There are 15 National Forests and a National Tallgrass Prairie. Regional boundaries contain more than 41% of the nation's population. The Eastern Region stands out as the most urban region of the country with nine of the top 20 metropolitan areas of the U.S. within the region's boundary.
